

# Terms of Use

## Frostgate VPN

By using the Frostgate VPN application or any related services, you agree to be bound by these Terms of Use. If you do not agree, please refrain from using the Service.

### Basic Terms

- You must be at least 13 years old to use the Service.
- You may not use the Service for any unlawful or unauthorized purpose. You must comply with all applicable laws and regulations.
- Unauthorized access to Frostgate VPN's internal API or systems is strictly prohibited.
- You must not interfere with or disrupt the Service, including through the introduction of malicious code.

Violation of these Terms may result in restriction of access to the Service at our sole discretion.

### General Conditions

- Frostgate VPN reserves the right to modify, suspend, or terminate the Service at any time, for any reason, without prior notice or liability.
